GIS Conference

Darin VanDeBerg (GIS Technician) traveled to San Diego for the annual ESRI International GIS User Conference and filed this report: There were more than 12,000 people worldwide who attended the weeklong conference at the San Diego Convention Center. ESRI, the GIS software and mapping provider, offers this event to people who use their GIS mapping applications.

I attended numerous technical training workshops taught by GIS professionals on how to use the newest version of ArcGIS10, how to build and cache online mapping applications, and learned the newest Tips, Tricks, and Shortcuts on ways the maximize your GIS performance. Exhibits were also very useful as it provided hands on training on their newest version of ArcGIS. I also attended the plenary session, a daylong event about sharing insight and vision on the future of GIS. Many speakers, videos, and awards were demonstrated on the newest capabilities. I went to the Map Gallery showcase, one of the most comprehensive and innovative display of more than 800 maps. The conference concluded with Gala, a celebratory fiesta, compliments of ESRI.

I met many new faces, learned new efficient and practical ways on how to better our work and create bigger goals for Minnehaha County GIS. It was a great opportunity for me to travel to beautiful San Diego and learn the newest and exciting ideas that GIS has to offer.

DRAINAGE ORDINANCE AMENDMENTS

The drainage taskforce completed their review of the existing drainage ordinance after holding three meetings for public input and four working sessions. The taskforce is proposing amendments to the ordinance that would

- Increase the length of time a drainage permit is valid;
- Increase the number of properties covered by one drainage permit;
- Increase the depth allowed for manmade and natural ditch cleanout;
- Allow some drainage into intermittent streams.

Following State and County regulations, the proposed amendments will be presented to the County Commission on October 4th. The purpose of this meeting is to inform the Commission and the public that changes are being suggested to an adopted ordinance, but no public testimony will be taken at the meeting. The public hearing, where all interested parties can address the proposed amendments, will held on October 26, 2010 as part of the regularly scheduled County Commission meeting. That meeting will begin at 9:00 am and is held on the second floor of the County Administration Building, located at 415 N. Dakota Ave., in Sioux Falls.
